The MHSAA Ski Committee met (via conference call) on November 3, 2009. The committee was reminded of its responsibility and of the process for rule changes. The following action was taken.

Proposals By MHSSCA

1. Change the wording in the MHSAA Ski Manual 2D(3) to read: All individual qualifiers shall race in flights 2.5 and 4.5 with equal distribution in each flight. In the event there are an odd number of skiers, the additional skier shall be placed in 4.5.
2. NEW: The Course Review Committee shall be made up of each member of the Jury.
3. Add: 7FI – Meet Managers and the TD shall facilitate communications amongst all participating coaches regarding course setting. At the Regional level, participating schools will be represented in the course setting. At the Final level, each region shall be represented provided qualified personnel are available.
4. Add: 7B3- In slalom, a minimum of 1 flush (3-4 gate combination) and 1 hairpin shall exist per course.
5. 8D Administration – Providing workers
Each qualifying team shall provide 1 worker for both the morning and afternoon events. This shall be applied to each gender. In the event the position is not filled with a qualified individual by that school, the head coach or member of that school's coaching staff will fulfill the responsibility assigned to the school. If a coach refuses to fulfill the responsibility, this is an unsportsmanlike conduct issue.
6. Course Management Proposal
Eliminate all outside gates. Exceptions:
 - A. First and last gate
 - B. All combinations (flushes & hairpins, including the exit and following gate)
 - C. All through and delay gates
