**PROPOSALS BY MHSSCA**

1. If an individual skier qualifies in one discipline at the MHSAA Regional Tournament, the skier will ski both disciplines at the MHSAA Final.
2. All vertical combinations shall be set with an "over the top" pathway for the racer to follow (turning gate shall be the top gate of the combination).

### NEW BUSINESS

1. "Alpine Ski Manual" (8D Administration – Providing workers).  
Require each qualifying team to provide two workers for both the morning and afternoon events. This would be applied to each male and female event. Failure to comply would subject the team to existing unsportsmanlike conduct sanctions consisting of 5 points added to the team's total score.
2. Lycra Bibs – Recommend the MHSAA purchase Lycra bibs instead of paper bibs for the Final Tournament for a three-year period at no additional expense.

### RECOMMENDATIONS TO THE MHSAA REPRESENTATIVE COUNCIL

1. If an individual skier qualifies in one discipline at the MHSAA Regional Tournament, the skier will ski both disciplines at the MHSAA Final. (7-2)
2. Amend the Alpine Ski Manual (8D Administration – Providing workers) to require each qualifying team to provide two workers for both the morning and afternoon events. This would be applied to each male and female event. Failure to comply would subject the team to existing unsportsmanlike conduct sanctions consisting of 5 points added to the team's total score. 3. Recommend the MHSAA purchase Lycra bibs instead of paper bibs for the Final Tournament for a three-year period at no additional expense. (9-0)
