

2021 INDIVIDUAL FINALS INFO SHEET



Congratulations on qualifying for the **2021 MHSAA Individual Wrestling Finals**. Below you will find important information in regards to the event.

- Location:
 - Wings Event Center: 3600 Vanrick Dr, Kalamazoo, MI 49001
- Parking:
 - All parking will be at the Wings Event Center.
 - There is no additional charge for parking at the Wings Event Center.
- Schedule:
 - o Check-In, Inspection & Weigh-In: See attached schedule for your assignments.
 - Competition: See attached schedule for your assignments.
- Coaches:
 - The number of allowed coaches will be based on the number of qualifiers per school.
 - Please know that we have capacity limits that we must be mindful of.
 - o All coaches MUST have completed the online coaches' rules meeting earlier in the year.
 - o If a wrestler does not have a coach, their match will be held until a coach becomes available.

- Trainers:
 - Trainers (ATC) and doctors will be on-site for the event as well as inspection.
- Spectators / GoFan:
 - Each school will be sent a code for EACH qualifier
 - Each code is good for three (3) tickets
 - Each ticket is \$45 (\$48.25 after service fees)
 - Tickets are by Division
 - Codes only work for 1 day @ their own Finals location
 - GoFan will send codes & ticket-buying links MONDAY (3-29-21)
 - No "Public" sales will be available for the Individual Wrestling Finals.
 - WEC: Valley Venue Seating: Space is limited in the Valley venue. To accommodate physical distancing, please utilize the top walkway, as well as the glass overlook areas that wrap all the way to the south end of the Valley Arena.
 - WEC: Main Arena Seating: Spectators will adhere to physical distancing guidelines dictated by the Wings Event Center staff.
- Testing:
 - Rapid testing <u>MUST</u> be conducted by your school using the following schedule:
 - D3: THR 4-1-21 TESTING (not before 10:00AM)
 D1: FRI 4-2-21 TESTING (not before 10:00AM)
 - o Schools MUST follow all testing protocols and procedures.
 - Administration will use the <u>Home Weigh-In Form</u> (that they have used all year) to attest that competing wrestlers have completed their test and are <u>APPROVED</u> for competition.
 - School administrators will print a copy of this completed "Home Weigh-In Form" FOR EACH INDIVIDUAL QUALIFIER THEY HAVE.
 - EXAMPLE: If you have 6 Individual Qualifiers from your school, you will print <u>6</u> copies of this same form, and give one to each wrestler to present at inspection.
 - This form will serve as each wrestler's "ticket" to be inspected and weighed in.

By having school administration confirm that all wrestlers have passed their COVID test prior to arrival allows for on-site inspection, weigh-in and competition.

• Inspection:

- Inspection will take place <u>ON-SITE</u> utilizing the following schedule:
 - D3: THR 4-1-21 Inspection/Weigh-In (6:00PM) @ Wings Event Center (Valley Arena)
 - D1: FRI 4-2-21 Inspection/Weigh-In (6:00PM) @ Wings Event Center (Valley Arena)
- EACH INDIVIDUAL WRESTLER WILL HAVE A COPY OF THEIR SCHOOLS "HOME WEIGH-IN FORM" THAT THEY PRESENT AT INSPECTION.
 - This form will serve as each wrestler's "ticket" to be inspected and weighed in.
- By having school administration confirm that all wrestlers have passed their COVID test prior to arrival allows for on-site inspection, weigh-in and competition.
- For inspection, Officials will use the "Home Weigh-In Form" supplied to Tournament Management from each school that assures a passed COVID test for inspection of participating wrestlers. Officials will use this to identify each wrestler from a specific team during the process.
- All participating wrestlers must be in a suitable undergarment for inspection, that completely covers the buttocks and the groin area. Female contestants must wear a suitable form-fitted compression undergarment that completely covers their breasts and minimizes the risk of exposure.

• Weigh-In:

- Weigh-In will take place <u>ON-SITE</u> utilizing the following schedule:
 - D3: THR 4-1-21 Inspection/Weigh-In (6:00PM) @ Wings Event Center (Valley Arena)
 - D1: FRI 4-2-21 Inspection/Weigh-In (6:00PM) @ Wings Event Center (Valley Arena)
- o **Rule 4-5-7 Note: ART. 7...** All contestants shall weigh-in wearing a legal uniform (4-1-1) and a suitable undergarment that completely covers the buttocks and the groin area. Contestants shall not weigh-in wearing shoes or ear guards. Female contestants shall also wear a suitable form-fitted compression undergarment that completely covers their breasts. Contestants may wear low-cut socks that cannot be removed or added if the wrestlers do not make weight.
- O As wrestlers are required to weigh-in in a legal uniform, scales can be moved to open areas as well.
 - A legal uniform would be a normal school singlet as produced by the manufacturer (unaltered) that could or would be worn during a normal MHSAA competition.
- O NOTE: FACE COVERINGS MUST BE WORN DURING WEIGH-IN, INCLUDING WHEN ON THE SCALE.

• Credentials:

- Wrestlers and coaches will receive credentials at check-in for inspection/weigh-in.
- Sharing of credential will result in removal from the event.

• Format:

- o Matches will take place on eight (8) mats. 4 mats will be in the Valley, and 4 mats in the Arena.
- Wrestlers, coaches and spectators should follow TrackWrestling in regards to mat assignments, as we may only announce mat assignments for the Finals.

Face Coverings:

- Face coverings MUST be worn at all time, except for those wrestlers competing on the mat during their match.
- Face coverings MUST be worn at all times by all others during the event.
- o Please review earlier publications in regards to face coverings.

• Food:

- Wrestlers: May bring personal quantities of food in clear bags, and personal drinks in clear containers. **NO COOLERS ALLOWED**.
- Spectators: NO FOOD WILL BE ALLOWED TO BE BROUGHT IN BY SPECTATORS.
- Concessions: Will be available throughout the day.

Entrance / Exit:

• There is NO RE-ENTRY during the event. If you exit the facility you will <u>NOT</u> be allowed to re-enter.

Warm-Up:

o See attached schedule (below) for your Division.

Hotels:

- Schools must secure their own hotel accommodations if they choose that option.
 Schools are responsible for all costs associated with travel, hotels, meals, etc.

Seeding:

- o The four (4) Regional Champions were seeded by committee on **SUN 3-27-21**.
- o The remaining brackets are then built by formula.

Coaches Meeting:

- The coaches meeting will be held virtually.

March:

o In an effort to minimize and reduce risk as much as possible there will be no opening March or Grand March this year.

Awards:
